THE MIZORAM ELECTRICITY REGULATORY COMMISSION ADOPTION OF LAWS AND ORDERS, 2024

No. A.12031/1/2024-MZERC/1, the 26th July, 2024. Whereas, upon the expiry of the Memorandum of Agreement signed between the Government of India and the states of Manipur and Mizoram on 22/7/2024, the Government of Mizoram has constituted a State Electricity Regulatory Commission named "Mizoram Electricity Regulatory Commission" as per the Power & Electricity Department, Government of Mizoram Notification No. A.11019/1/2023-P&E dated 19.07.2024.
